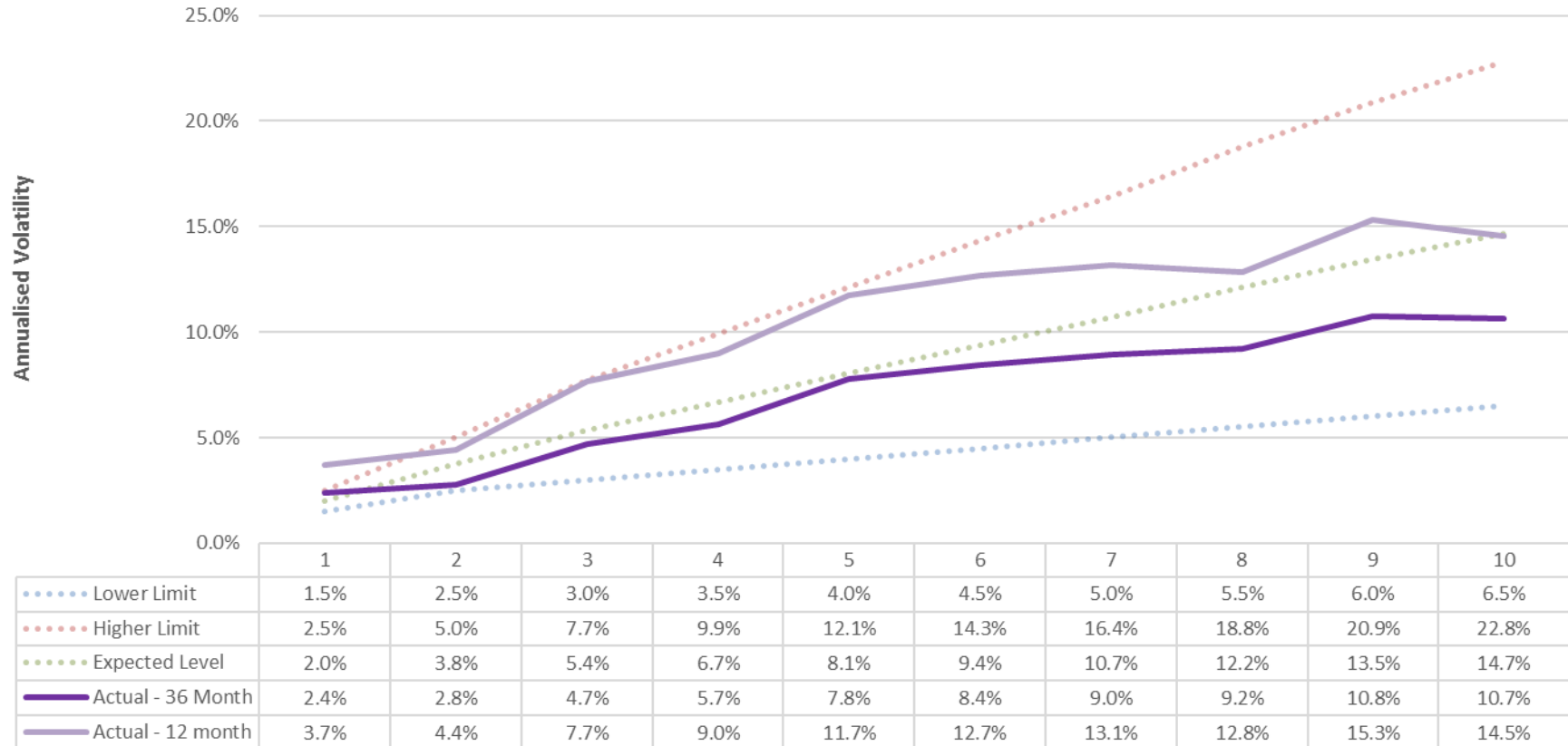

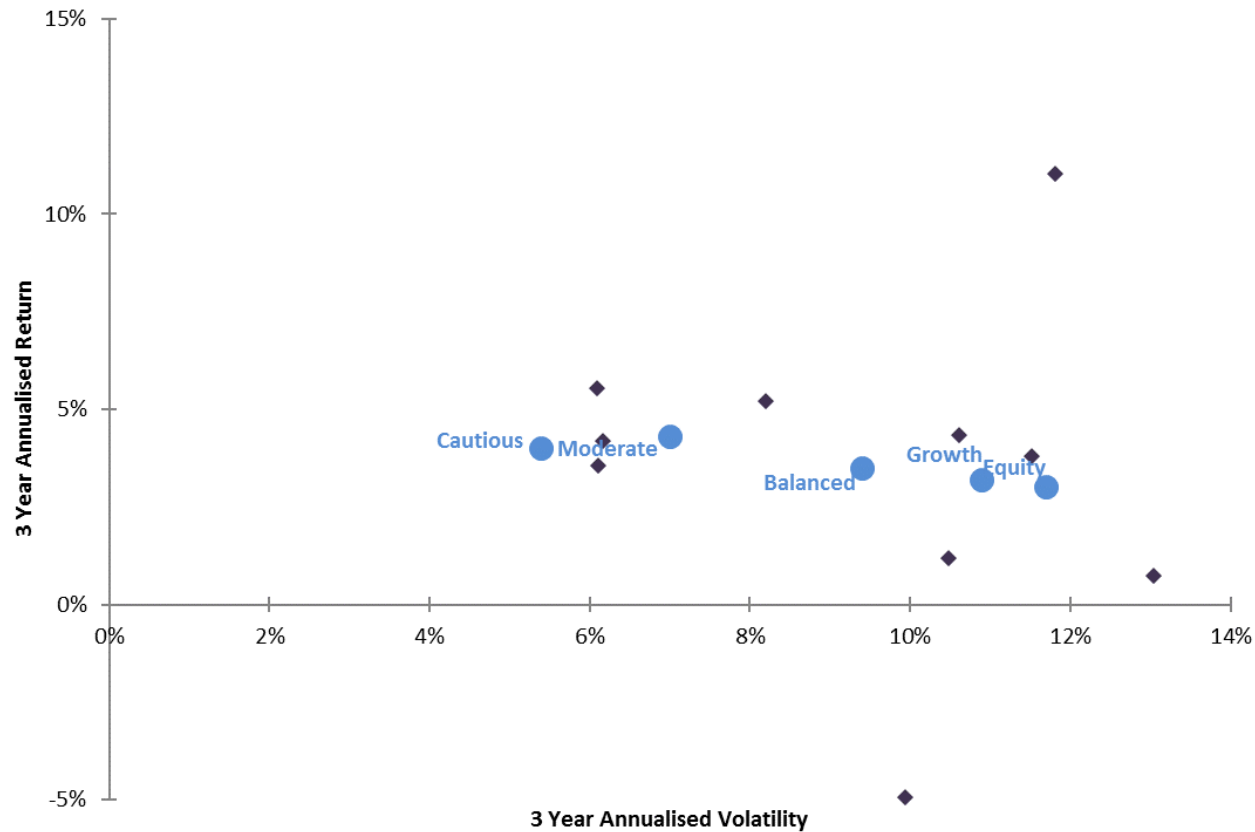

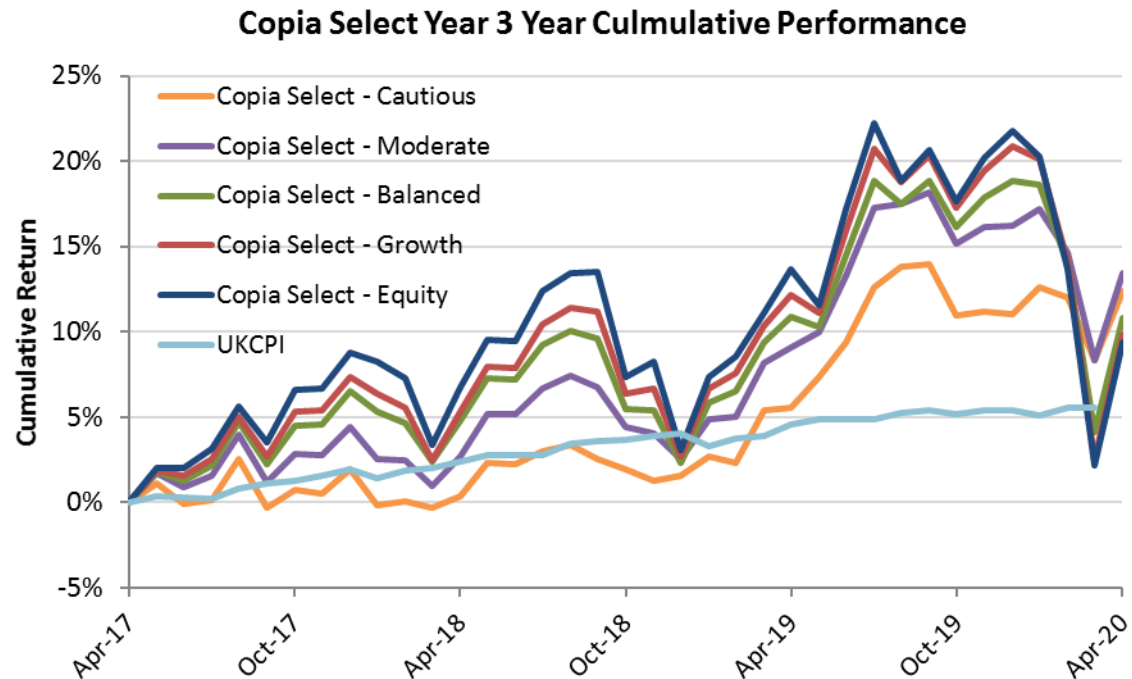
Outcome (risk-return) analysis as at 30 April 2020

Outcome (3 year cumulative return) analysis as at 30 April 2020



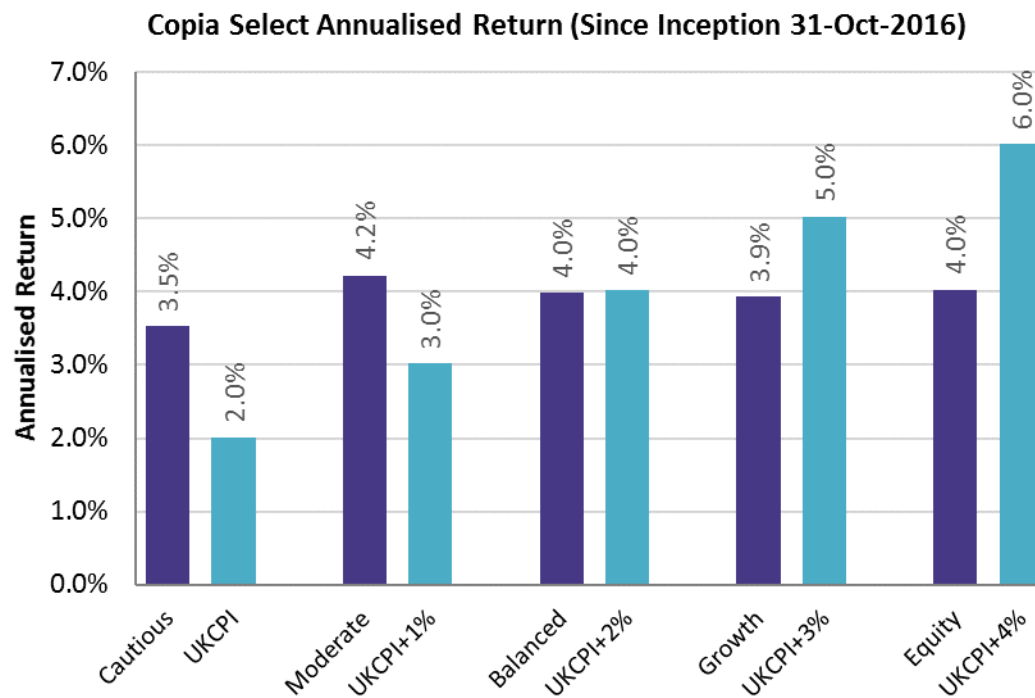

Outcome (since inception 31-Oct-2016) analysis as at 30 April 2020



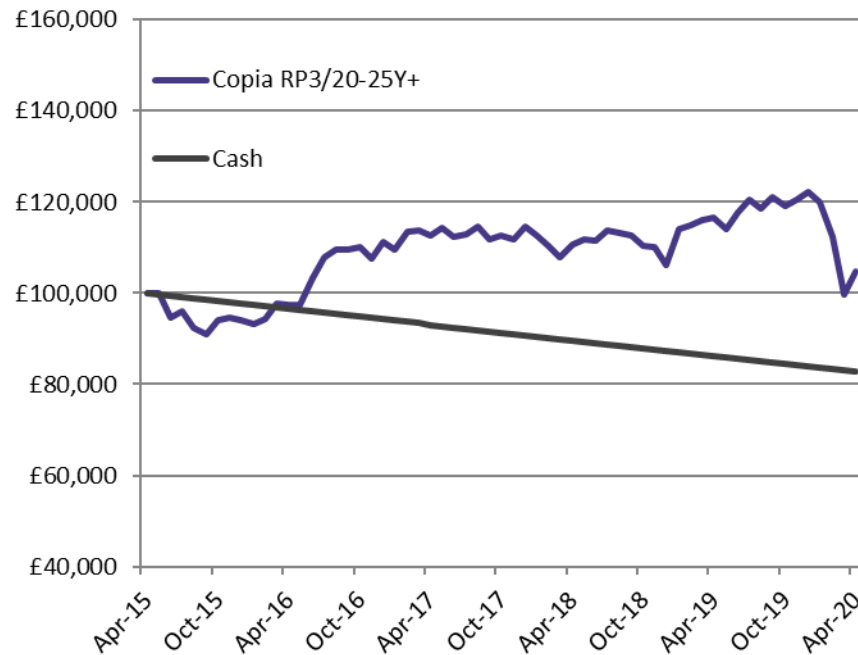

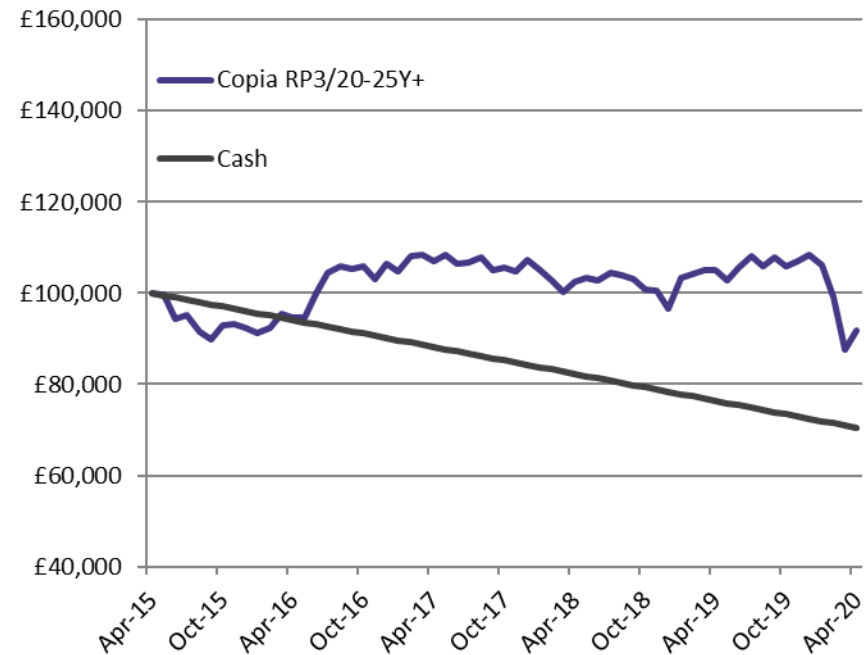

**Withdrawal Rate (50% Confidence): 5.91%**

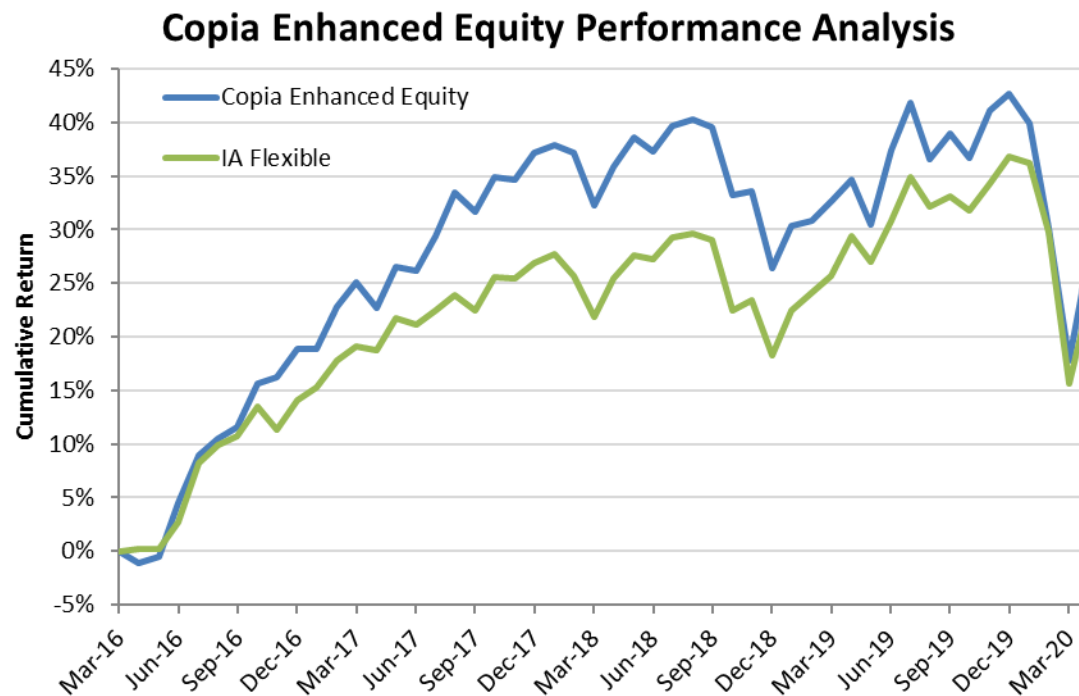
