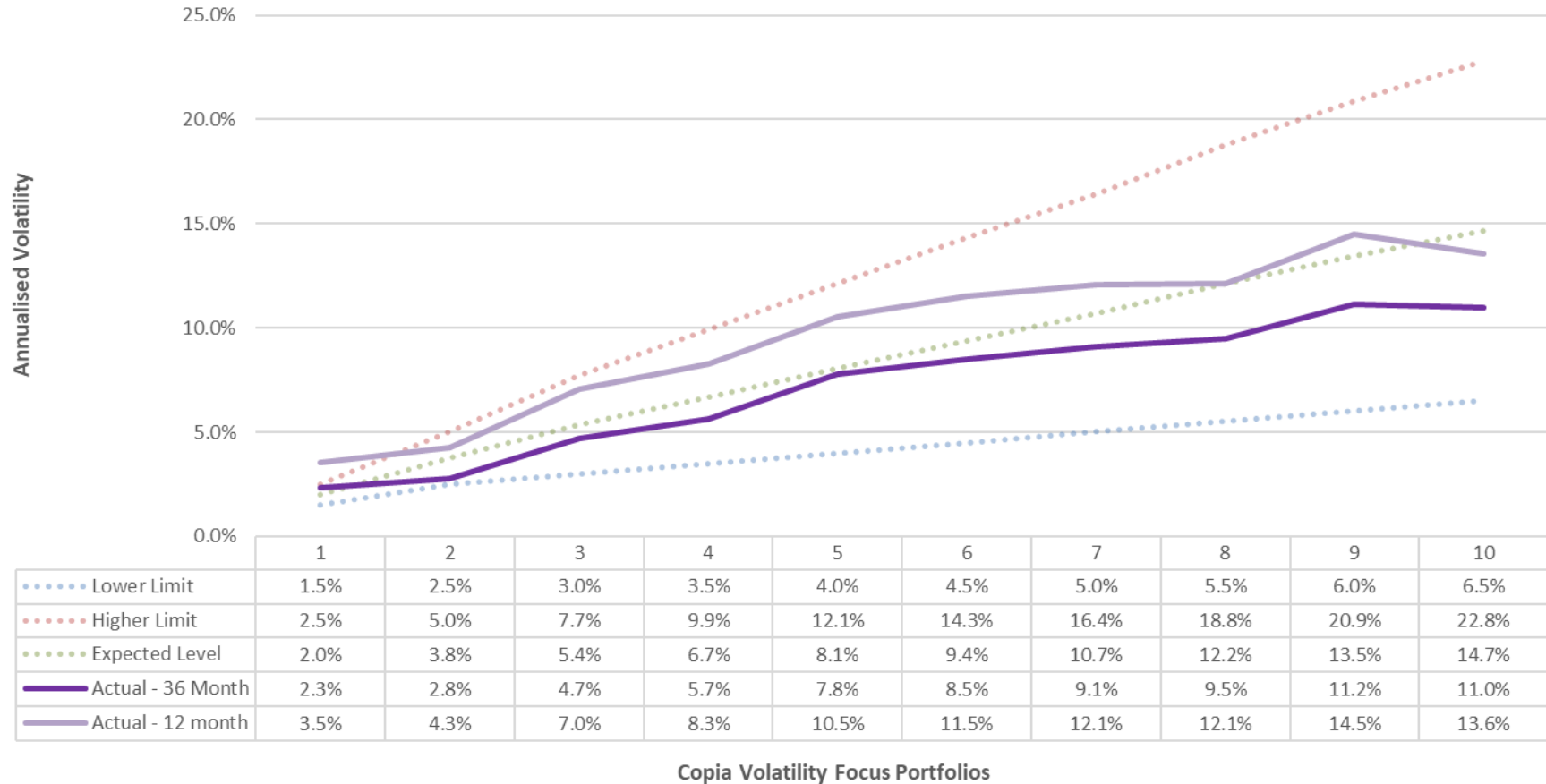

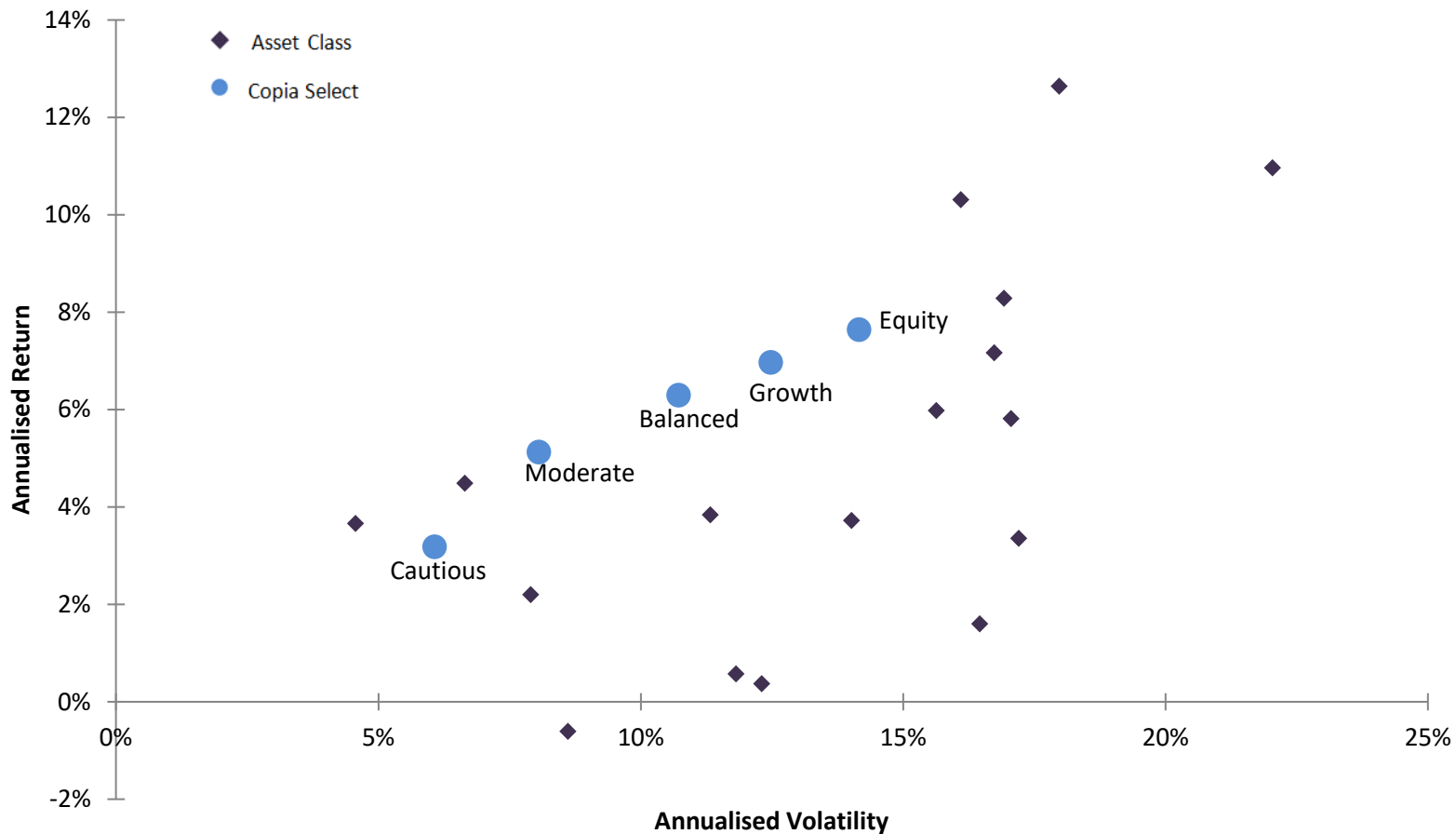
Outcome analysis as at 28 February 2021

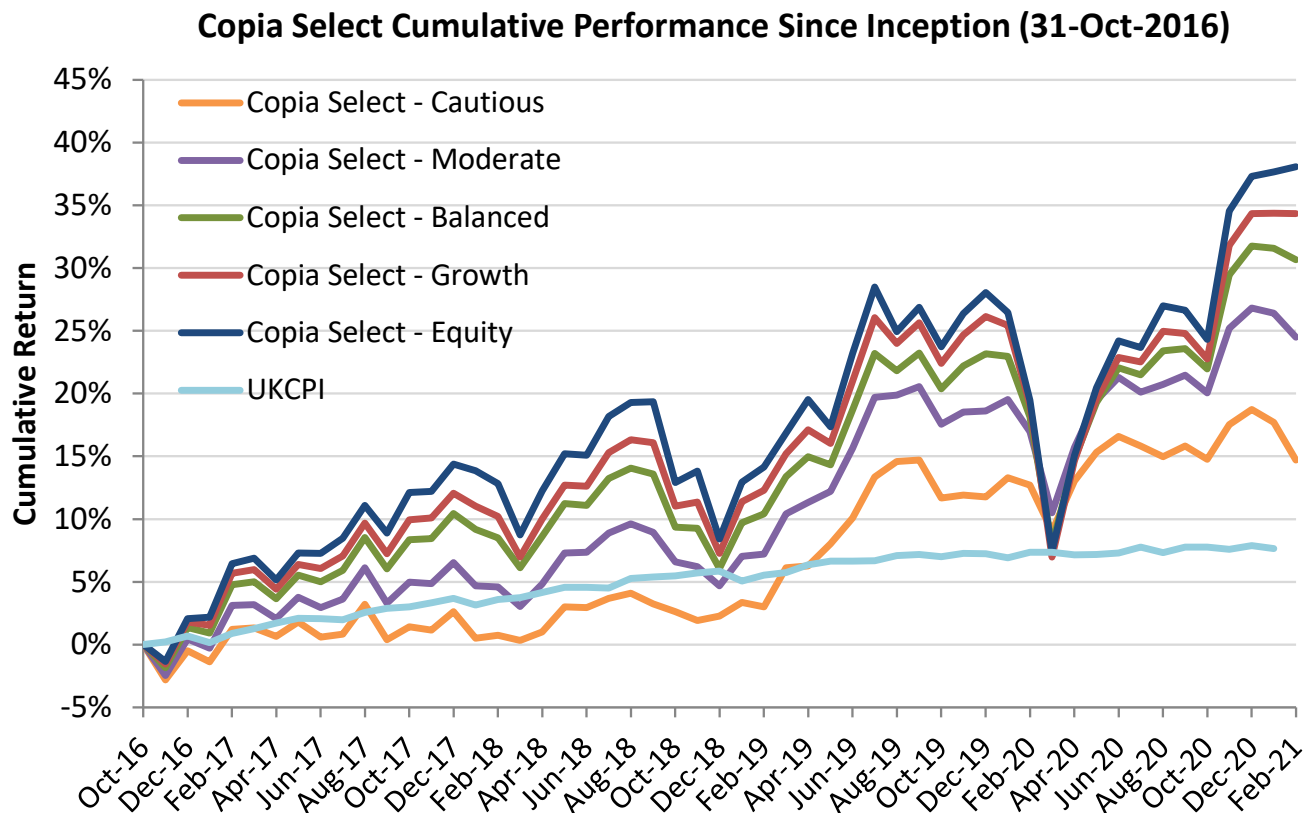
Outcome (risk-return) analysis as at 28 February 2021

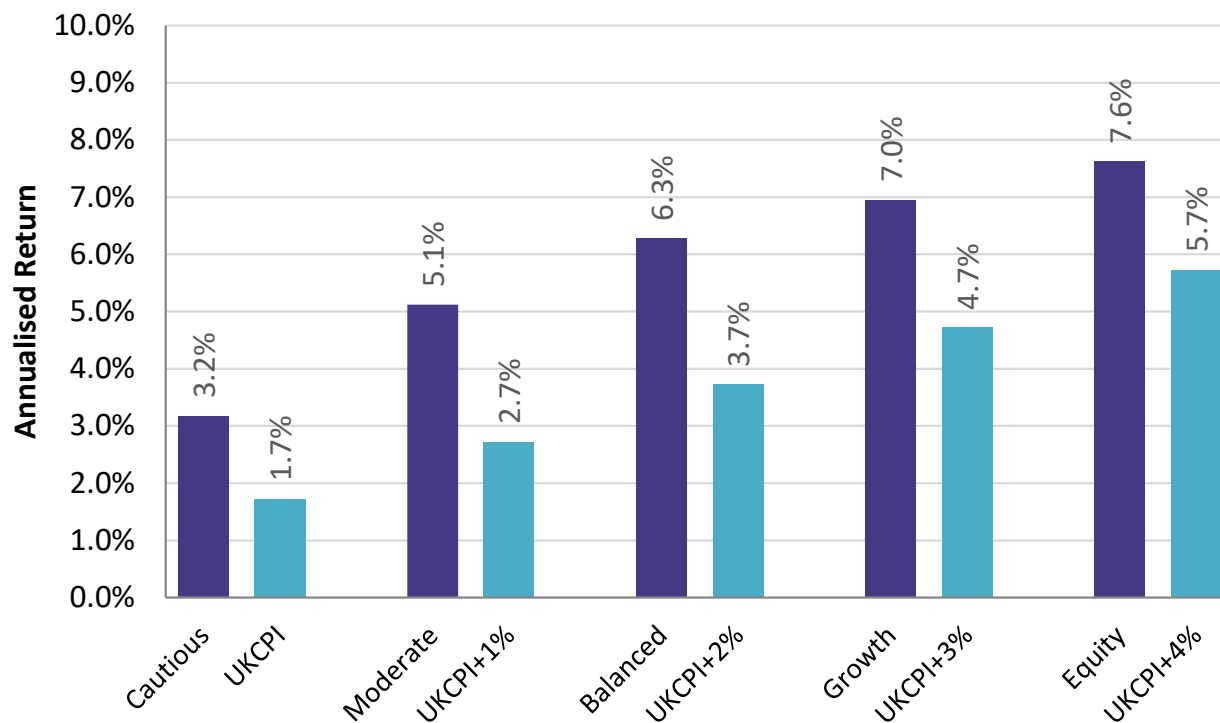

**Copia Select Annualised Return Since Inception (31-Oct-2016)**



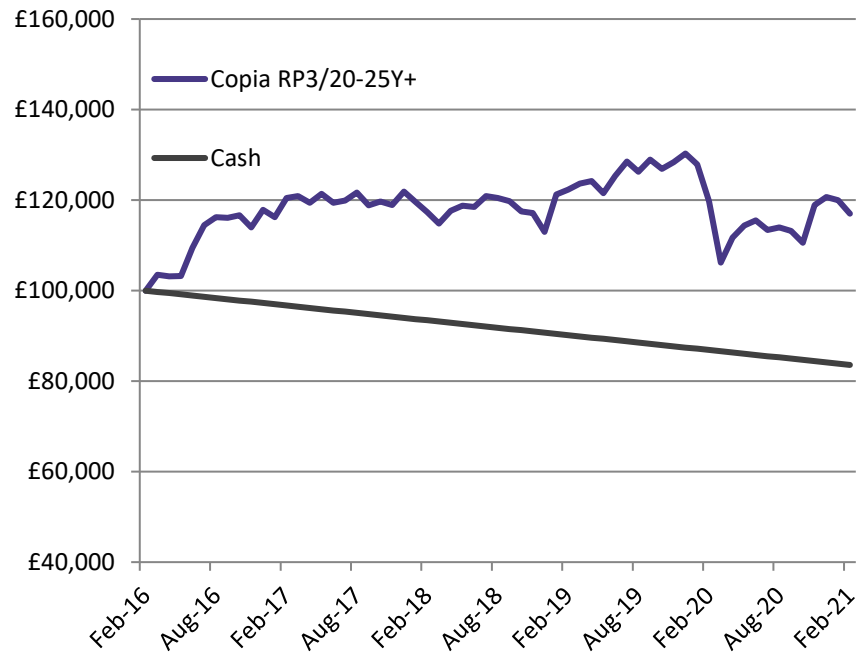

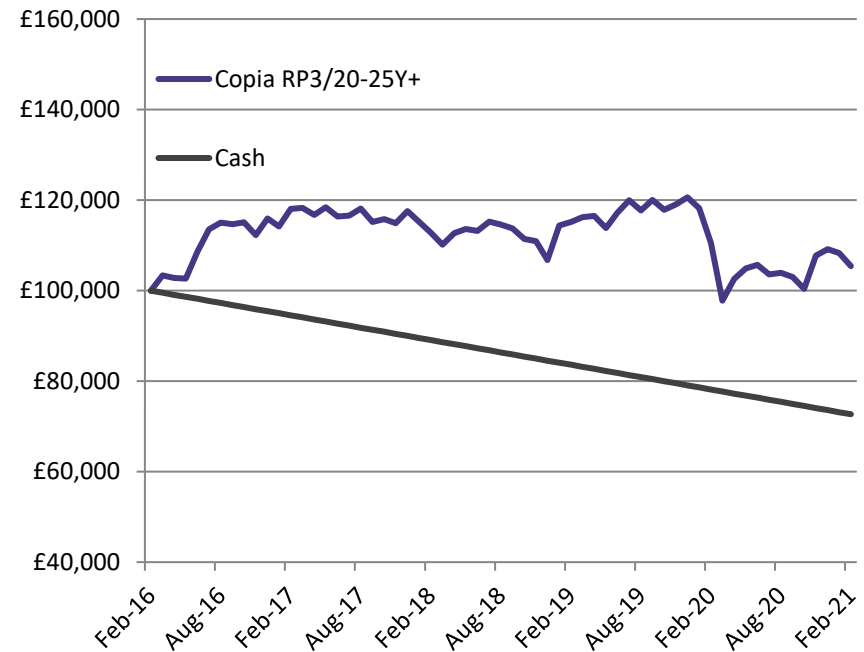

**Withdrawal Rate (50% Confidence): 5.46%**

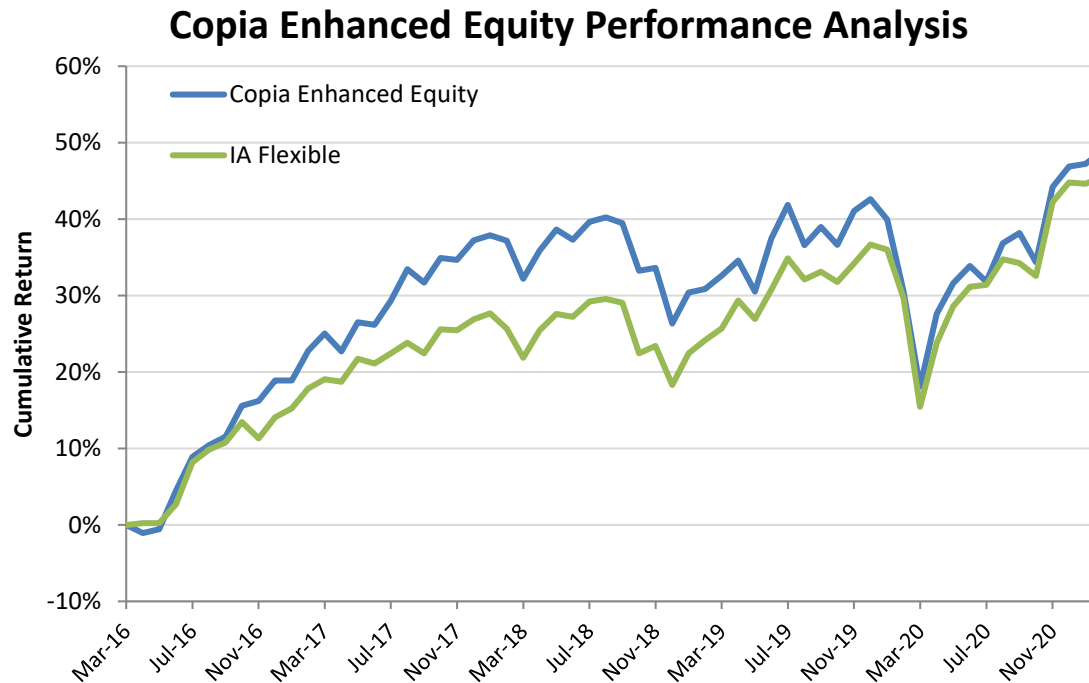
