

Outcome analysis as of 31 August 2022







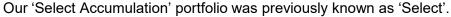

Select Accumulation and Select ESG Cumulative Performance Since 31-Oct-2016










Select Accumulation and Select ESG: outcome chart



Outcome analysis as of 31 August 2022




