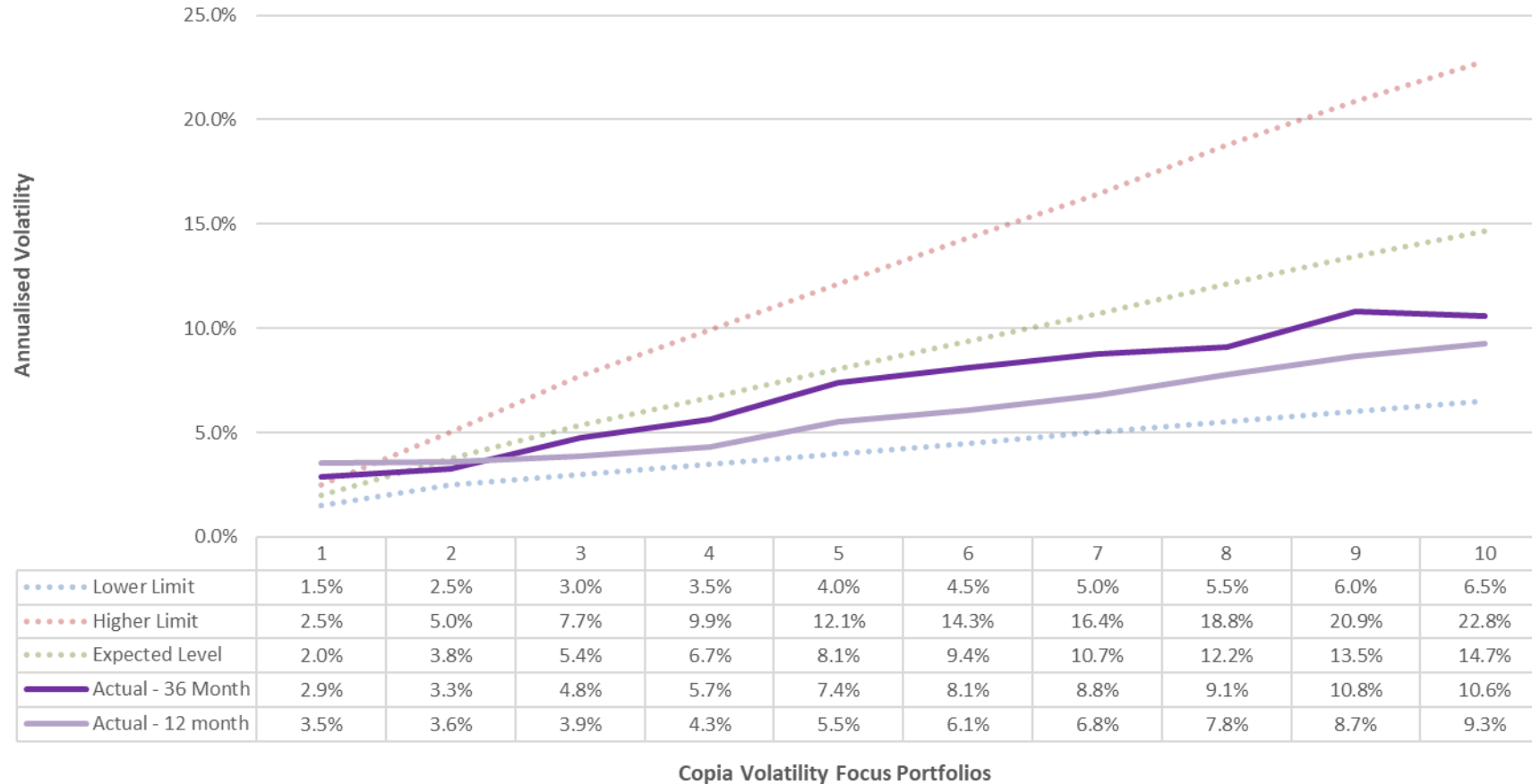

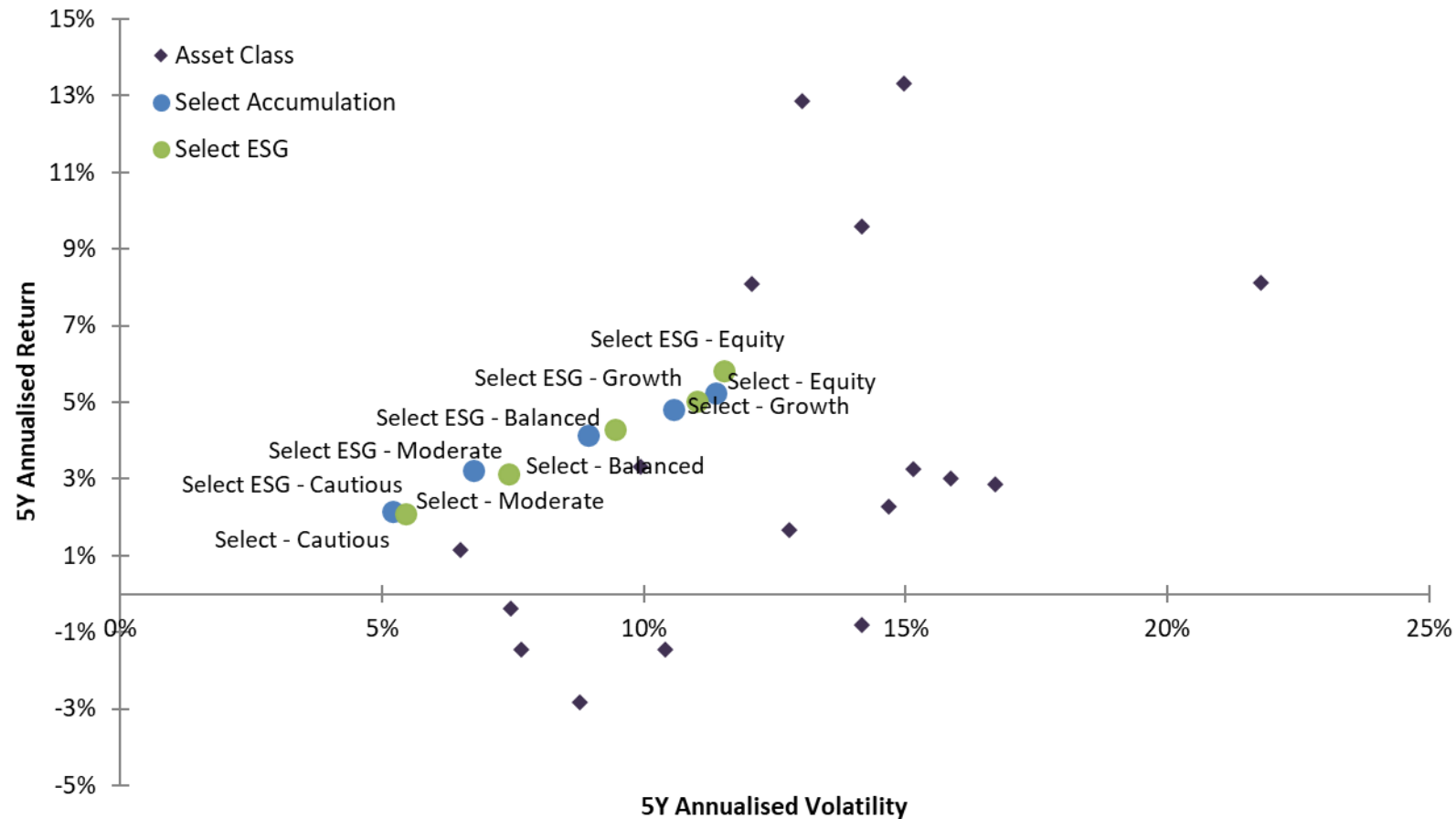

Outcome (risk-return) analysis as of 31 October 2022

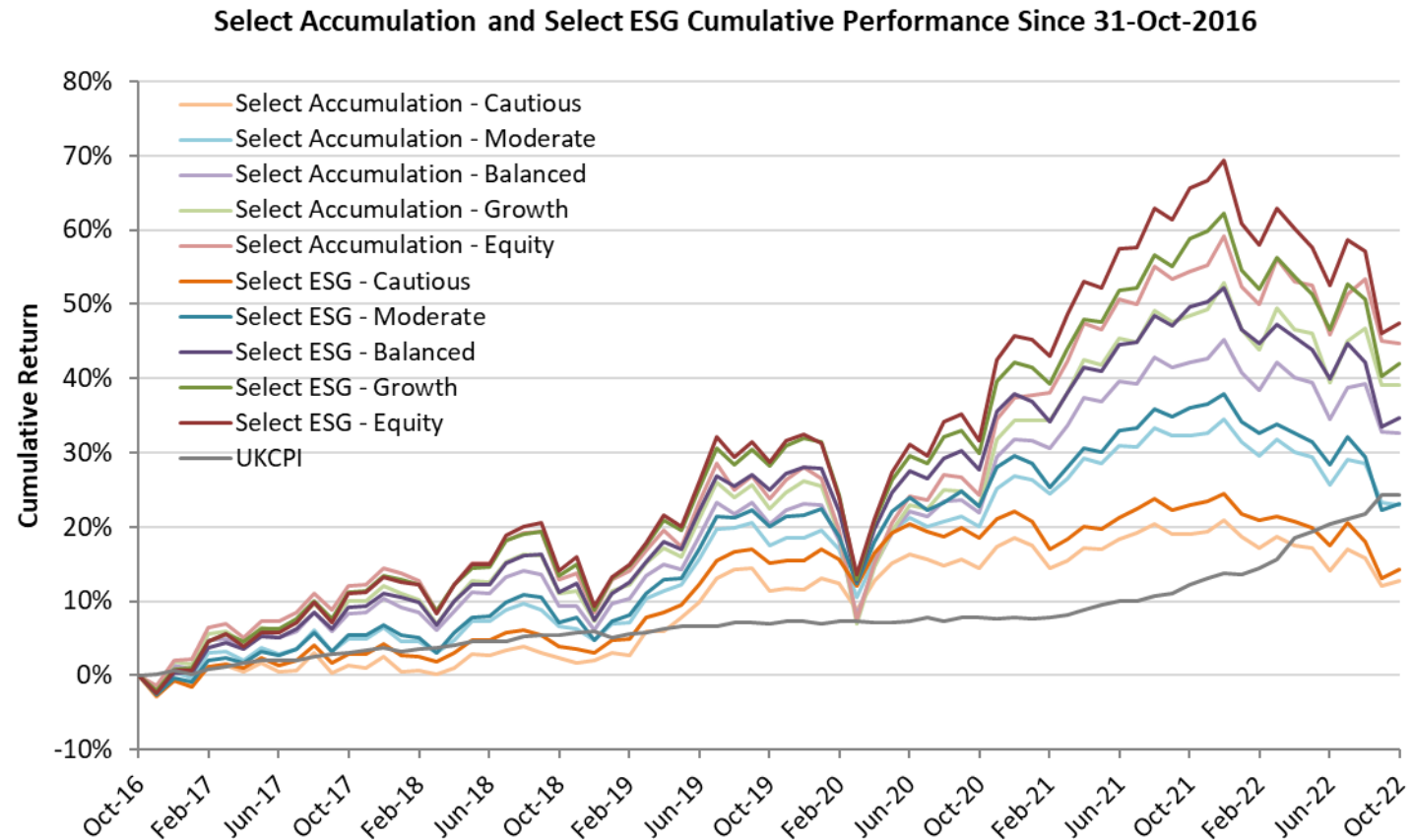

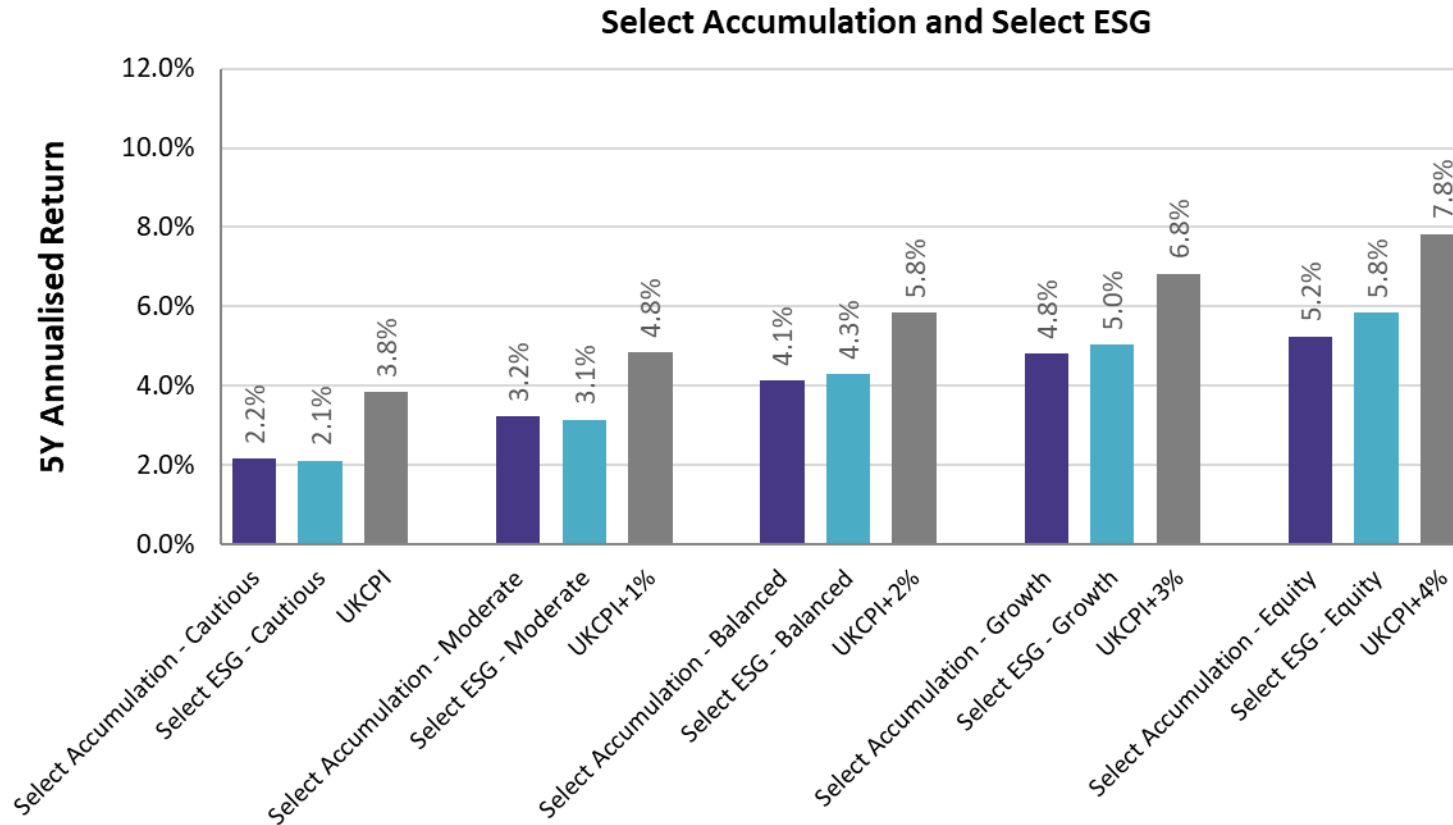

Outcome analysis as of 31 October 2022

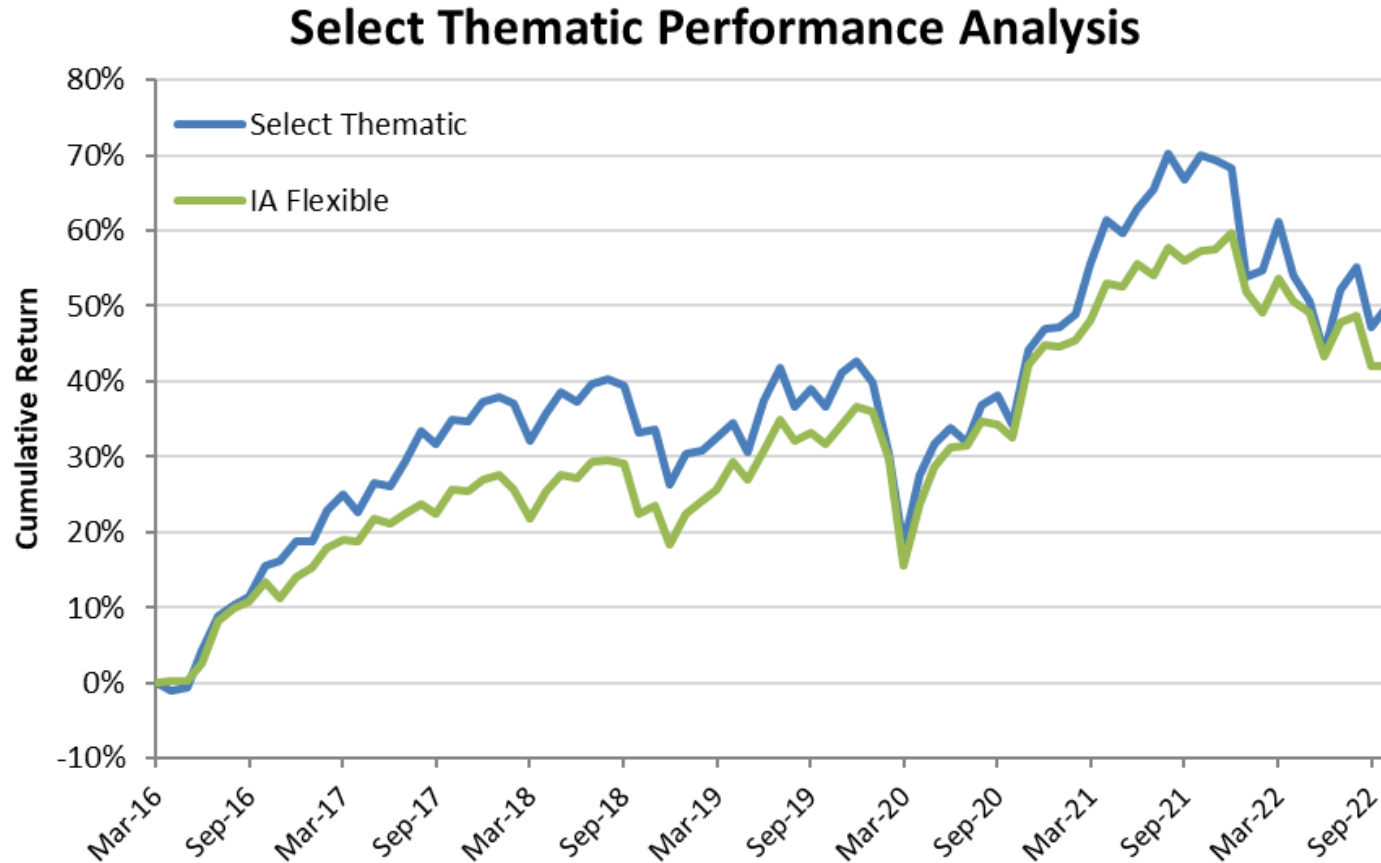
