

Outcome analysis as of 31 January 2023





Outcome (risk-return) analysis as of 31 January 2023







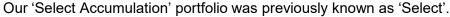



Outcome analysis as of 31 January 2023


